<b>What is the overall <a href="#">deductible</a>?</b>	In-Network \$4,000 Individual or \$8,000 Family. Does not apply to pharmacy. <a href="#">Copays</a> do not count toward any <a href="#">deductibles</a> . No out-of-network coverage.	Generally, you must pay all of the costs from <a href="#">providers</a> up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay. If you have other family members on the <a href="#">plan</a> , each family member must meet their own individual <a href="#">deductible</a> until the total amount of <a href="#">deductible</a> expenses paid by all family members meets the overall family <a href="#">deductible</a> .
<b>Are there services covered before you meet your <a href="#">deductible</a>?</b>	Yes. ### Does this Coverage Provide Minimum Essential Coverage? Yes.
