A Fresh Take on Medicare Supplement

Avera Health Plans is offering two new Medicare Supplement plans to members. Both are great options and have many similarities but one plan is offered to those living in specific South Dakota counties. Please see below for details.

Avera AgilityPlus Standard Plan

This plan will be offered throughout the state of South Dakota to be purchased by those that meet the regulatory requirements and qualify to buy a Medicare Supplement plan through a carrier located in South Dakota. Avera Health Plans will offer both a high deductible health plan and a household discount option.

Avera AgilityPlus Select Plan

This plan will only be offered in nine counties (Lincoln, Minnehaha, McCook, Davison, Hanson, Yankton, Hughes, Stanley and Brown) in the state of South Dakota, to be purchased by those that meet the regulatory requirements and qualify to buy a Select Medicare Supplement plan through a carrier located in South Dakota. Avera Health Plans will offer both a high deductible health plan and a household discount option of the plan. As with all Medicare Supplement plans, it can be purchased by those who meet the regulatory requirements and qualify to buy a Medicare Supplement plan through a carrier located in South Dakota.

Both plans will offer these new and innovative benefits:

- Annual routine physical exam once every 12 months
- Hearing Exam & Aid Fitting for new patients
- Heart and Vascular Screening
 - Coverage of screening through Planet Heart program with Avera at one of the 20 locations offered throughout SD.
- Active Life Wellness Program
 - \circ \$10 reimbursement after attending the gym at a NIHCA participating facility after attending 8 times per month

Let the Countdown to Cohere Begin

In our continued efforts to ensure that our members are receiving the right care, Avera Health Plans will add a new enhancement to the Utilization Management program by partnering with Cohere Health. Cohere is a clinical intelligence company with a platform that enables an improved digital experience for providers and their support staff. Along with the improved digital experience, Avera Health Plans will be expanding the list of services that require prior authorization.

Beginning Sept. 16, prior authorizations for Musculoskeletal (MSK), Cardiac Services, and Advanced Imaging must be submitted through Cohere Health, which will be accessible through the Avera Health Plans provider portal. Only providers who are servicing Avera Health Plans members in the Avera Network area and file their claims directly to Avera Health Plans will experience these changes.

To best prepare, impacted providers should <u>register</u> with Cohere Health prior to Sept. 16.
